INSAF's TSUNAMI RECONSTRUCTION PROJECT GETS UNDERWAY AT HUT BAY, ANDAMAN & NICOBAR ISLANDS

On the morning of Sunday, 26 December 2004, a severe earthquake in the ocean off the coast of Sumatra caused tsunamis that devastated communities in the coastal areas of 12 countries in the Indian Ocean. These tsunamis swept people out to sea, and destroyed homes, roads, schools — a disaster of extraordinary proportions.

Similar to the events after the Gujarat Earthquake in 2003, the INSAF leadership recognized that the larger, international relief agencies and governments are better equipped to provide immediate relief, but that it was our duty to help with reconstruction after the media attention has turned to other matters. During the last 8-9 months, INSAF has searched for a suitable project through scores of consultative meetings, phone calls and e-mails. We are pleased to report that INSAF has agreed to collaborate with SISS (Shymprasad Institute for Social Service) to launch a project to be called AKSHARA in Hut Bay, the main settlement of 12,000 in the little Andaman. Hut Bay, which faces the open ocean and is only a few hundred miles from Sumatra, suffered considerable damage after the tsunami. Seven of the 11 schools were damaged. SISS, headquartered in Hyderabad, AP, has been working on a sanitation project in Port Blair, the capital of the Andaman & Nicobar islands.

Under project AKSHARA, about 304 high school students will be provided their text books. In addition, a modest library/career center will be set-up at the Government Senior Secondary School in Hut Bay. The library/career center will have some bookshelves and books, a few chairs and desks as well as one computer. A few community meetings will also be organized under the project to provide support, career guidance and health promotion.

The 2005 budget for the project is \$5,000. As of the date of this Newsletter, a total of about \$4,000 has been contributed by: Ashok & Darshan Mehan, Santosh Chokhani, P. & Shakunthala Harshavardhana, Ashok & Usha Sachdev, PK & Suresh Malhotra, Kumar & Sudesh Kapur, Soma & Parvathi Murthy, Raj & Padmeshri Lad, Bhav & Kaye Sharma. This means this project needs your help. Kindly send your tax-deductible contribution in whatever amount you feel comfortable with — as soon as possible — to INSAF.

Efforts are being made to see if internet access is affordably feasible for the proposed computer at the Hut Bay School Library/Career Center. Therefore, the 2nd stage of the project will be defined sometime in early 2006. Please feel free to e-mail the Newsletter Editor with any questions on this project.

NEW PROJECT: VILLAGE ADOPTION

A small group of families in Northern California has been meeting over the past 6-9 months to consider what sort of a project they might like to sponsor. The group, which informally calls itself the "Palo Alto Group" because many of them work in Palo Alto, California, has decided that they would like to "adopt" a small village in India, and then work for the development of that village with a long term commitment.

The Palo Alto Group will be working with SODHANA, headquartered in Chipurupalli, Andhra Pradesh, to adopt a village in that area. - ◆ Conduct bridge classes in the evening for 3rd to 5th grade students.
- ◆ Conduct "Health Check-up Camps" twice a year
- ◆ Conduct group discussions with a select group of women and youth on health and general awareness topics.

LETTER TO THE EDITOR

A general observation and a question from Dr. Prem N. Bajaj is provided below.

1. A remarkable feature of INSAF's working is its low operating cost. Almost all of the donations go towards the projects. In most cases, the members pick up even the postage costs.

There is no paid position in INSAF. It is surprising to see an organization having functioned, exclusively by volunteers, for thirty six (36) years. Just look around and you will find that most non-profit associations have high operating budgets - 15 to 20 percent is quite common.

INSAF has no rental costs and no utilities to worry about. So wonderful, indeed.

2. So far we talked of life memberships for individuals/families only. If a business likes to be a life member, what will be the contribution ?.

Perhaps a donation of \$ 100 for a small business and \$ 150 for a larger one should be a good beginning. It gives us more exposure to the public and makes the business look good at the same time.

3. At times, I feel that we should give more publicity to the causes of INSAF. How ? May be, the executive committee can come up with some answers.

EDUCATION & HEALTH PROMOTION IN RAIPUR, CHHATISGARH, INDIA

Dr. Tarun and Dr. Kamal Kothari from upstate New York have in the past supported Professor Ram Chaudhari's efforts at the Bhulpur, UP village. The Kotharis have turned their attention to improving the health and education of the disadvantaged in the Raipur area in Chhatisgarh.

Thanks to the Kotharis, \$10,000 is being sent to support this work in the Raipur area. We look forward to hearing about the progress of the efforts.

BHULPUR SHIKSHA SAMITI, UP

One of the most exemplary and long-sustaining efforts for more than 20 years is the one led by **Dr. Ram Chaudhari**, Professor Emeritus of Physics, State University of New York, Oswego. Ram and his friends and family have been sponsoring the Bhulpur Shiksha Samiti in Bhulpur, Etawah District, UP, a small village of less than 1,000.

Ram and his friends took a near destroyed thatched-shed middle school in 1986 and have transformed it into a high-quality intermediate college. The Shiksha Samiti has done a lot to promote the education of children and adults, especially girl children. A Rural Center of Science Culture has been set up to promote practical science.

As a result of the continued commitment by Ram, his friends and family, a total of \$5,100 has been sent this year to the Bhulpur Shiksha Samiti.

"RIGHT TO INFORMATION" ACT IN INDIA

Corruption in India and other countries has been a major hindrance in the quality of life of a common person. A momentous law passed recently in India could have a revolutionary impact 10-20 years down the road. The Indian Right to Information Act was introduced to the Indian Parliament in July 2000. It came into effect on 12 Oct 2005. Under this law the information has become a fundamental right of an Indian citizen. Under this law all Government Bodies or Government-funded agencies have to designate a Public Information Officer (PIO). The PIO's responsibility is to ensure that information requested is disclosed to the petitioner within 30 days, or within 48 hours in case of information concerning the life and liberty of a person.

Prior to this, 9 states (Goa, Rajasthan, Maharashtra, Karnataka, Delhi, Tamil Nadu, Assam, and 2 more) had passed a similar law in recent years but now the all-country law takes over. A 29 page history entitled,

This is an update on two educational initiatives being supported by **Joginder and Meera Kundra**.

Bodh Gaya, Bihar is the site where the quest of Prince Siddharth was fulfilled after years of seeking the truth and the saga of Buddha began. He attained the supreme enlightenment and became 'The Buddha', the enlightened one. In Bodh Gaya, a follower and friend of Shri Vinoba Bhave named Shri Dwarko Sundrani, 84, runs a program to educate 1,100 children with the support from the Kundras. A check for \$3,300 was sent recently.

In Lathakhaman, Jharkhand, Dr. Subhash Chandra, who is a 1967 Physics Ph.D. from Caltech and now retired from a long professional career in the US, runs an NGO named the Village Hope Foundation. INSAF members have a 20 plus years history of steady support to Sodhana. In 2004, the support came from Santosh Chokhani, Ashok & Darshan Mehan, Bhav & Kaye Sharma. The following are excerpts from the 2004-2005 Annual Report from Sodhana.

Educational Activities

11 talented students were paid Rs. 28,828 to continue their academic studies. Sodhana also organized celebration of national festivals such as the Independence Day. Gandhi Jayanthi, Children's Day on 14th November and Teachers Day on 5th September were also celebrated by Sodhana in a fitting manner. On Children's Day, the cultural troupes from all the schools in which we are involved will participate and exhibit their talent in their chosen field of songs, dance, or acting under the banner of "PALLE PILLALA VINODA VEDIKA" (which means Village Children Entertainment Platform). This expenditure was met from donations to Sodhana — particularly we thank INSAF for their generous donations.

Medical Aid

Sodhana sanctioned Rs. 13,600 towards medical aid to the deserving on humanitarian grounds to meet medical expenses by them. This expenditure was also met from out of donations received from INSAF.

He was told he would have to give a bribe of Rs.2000 to obtain it. Our friend — an RTI-empowered citizen — just went ahead and applied for the ration card without offering any bribes. His neighbors warned him he would never get his ration card. They also told him how he would now have to keep visiting the rationing office. Some well-meaning friends suggested he should approach some non-governmental organization to take up his case, so that ultimately he would get his ration card. Our citizen had decided to become an enforcer of good governance. He found out in how many weeks everyone who paid bribes got their ration cards. He waited for an extra four weeks after
