### CONSTITUTION REVISION RATIFIED BY INSAF MEMBERSHIP

During 2014, INSAF has focused on updating the constitution. The primary reason for revisiting the constitution was to expand and modernize the INSAF organization structure. We took this opportunity to clear up some ambiguities in whether the required voting percentages are of the voting members or the entire membership.

INSAF organization structure and constitution had not changed since the organization's (i.e., Friends of Punjab University Alumni Association or FOPUAA) formation in 1972 and then a name change to Indian Schools Alumni & Friends, USA in 1994. In recent months, two-third of the membership has unanimously voted to ratify the changes. Thanks to those who all voted to ratify the new INSAF Constitution and the associated INSAF Organization Structure. Some days the ratification process felt like the 2000 Presidential election as the progress was slow.

The following are the highlights of the changes:

- The Executive Committee of 4 is replaced by the Board of Directors (BOD) consisting of 7 individuals.
- Four members of the BOD are responsible for introducing INSAF to others.
- Three of the Board of Directors form the Executive Management Team (EMT).
- EMT consists of The President, Vice President (Communications), and Vice President (Finance).
- The President chairs both the BOD and the EMT.
- All directors are elected every two years for two year terms.
- A Transition Coordinator is appointed by the President to help with the election of BOD members.

Self nominations are highly encouraged since we all know that for INSAF to succeed, we need self-starters on the Board. One of the objectives of the new organizational structure is to expand the leadership to help introduce INSAF to more people. As the founders age, the organization needs younger people with energy and new ideas in order to survive and grow.

## A SISTER IS BORN

We have a new INSAF sister organization. It is named INSAF India. The primary motivation for creation of the organization is to facilitate INSAF type work in India, both on behalf of INSAF USA and independently. INSAF India has been registered as a trust based in Patiala, Punjab but able to support projects anywhere in India. In the coming months, INSAF India plans to seek authorization so that donors can make contributions in Rupees and receive income tax exemption in India. The new organization was born largely due to the efforts of Bhav Sharma who has been spending a significant time teaching in India over the past two years with an eye towards doing more hand-on volunteer work.

## 2014 FINANCIAL PROJECTS SUMMARY

Our overall project effort this year was excellent — thanks to a continued commitment by both members and non-members. As of the time of this Newsletter, an INSAF record of \$117,200 has been sent to support the various projects. In comparison, in 2013 we funded \$103,000 for projects.

The effort this year has been propelled by supporters of Pratham Mysore, focused on literacy improvement among poor children in and around Mysore. The supporters this year to date have an impressive total of \$27,842, about 1.5 times the next highest funded project for the year. This has been accomplished thanks to Project Leaders Arun & Padma Cariappa and about 20 other non-member contributors.

Supporters of Kaliyuva Mane, a residential school for disadvantaged children near Mysore, have come up with over \$18,300, thanks to the efforts of Project Leader and Former Exec Harshavardhana, Former President Soma, and about 7 member and non-member contributors (See Page 4 for details).

The Kanchan Foundation in Mumbai, which works to enable other NGOs working in education, health care, and community living support, drew a support at \$16,600.

In memory of departed Shrimati Lalitha Vasudevan, the K. Vasudevan family and friends have continued to sponsor the DECC Trust in Kerala, which operates the Saraswathy Vidyalayam in Eagandiyur, Kerala with the vision of turning it into a Kerala Nalanda University, evoking the ancient 427 AD university in Bihar. This year \$15,000 has been sent as a result of these efforts.

The graduating Class of 1969 from the Department of Chemical Engineering, Punjab University, have upgraded the previously established scholarships at the Department. Over \$5,000 were sent to the Panjab University for this project. The scholarship will now be upgraded to INR 1,500 per month for 10 months for 4 students, one from each class: freshman, sophomore, junior, and senior. The scholarship is based on merit-cum-means. It also requires that the applicant should complete some positive community service volunteer work. See Page 5 for additional details.

All in all, a total of about 16 projects have seen their support this year at \$1,000 or more (read pages 3-6 for details on some of them).

## 2014 FINANCIAL MEMBERSHIP CONTRIBUTIONS SUMMARY

Arun & Padma Cariappa lead the 2014 contributions at the time of this Newsletter with \$16,000 which includes \$8,000 in corporate matching funds arranged by the Cariappas for the Pratham Mysore work. Shri K. Vasudevan Family and friends contributed with \$14,300 for the Sarsawathy Vidyalaya. Shri Anop and Radhika Vora, new Life-Members, have contributed an amount of \$10,150, and the Sita Foundation \$10,000. Shri Joginder and Meera Kundra have continued consistently their high commitment with \$10,000, which includes \$5,000 in matching funds arranged by Shri Kundra. Pankaj and Rupa Nanavati, contributed over \$5,000. Ms. Arundhati Malladi, also contributed \$5,000. All in all, this was a very good year. We all should take collective pat on our backs for contributing over \$126,900. In comparison, we raised over \$111,000 in 2013.

## KALIYUVA MANE STUDENTS PROJECT

### ALL 5 KALIYUVA MANE STUDENTS CLEAR 10th GRADE

Kaliyuva Mane, a residential school managed by the Divya Deepa Trust, supports over 100 children, out of which about 36 live on-site. A notable feature is that the children typically have economic, behavioral, and educational issues when they arrive at Kaliyuva Mane.

The latest news is that all 5 students from such backgrounds have cleared their 10th grade exam — one with 1st division and two with 2nd division. Ordinarily, these students would have likely dropped out all together. Thanks to Kaliyuva Mane, these students plan to study further and now will likely be successful members of the society.

From the INSAF side, Project Leader **Harsha with Shaku and his outside friends, Soma & Parvathi, Raj & Padmashri, Bhav & Kaye** have been supporting Kaliyuva Mane. Harsha and friends sent \$18,300 in 2014 to support the work at Kaliyuva Mane.

## ARYA GIRLS HIGH SCHOOL, BATHINDA, PUNJAB

In 2013, INSAF Exec Dr. Vimal Goyle successfully completed a good example of a "giving back" project. ## PRATHAM MYSORE CHILDREN SCORE WELL

In October 2014, the 7th batch of student teachers went through a certification test after coaching by Pratham Mysore. The certificate course in preschool education is conducted in coordination with Karnataka State Open University.

Of the 21 student teachers in the 7th batch who appeared in the certification test, four passed with distinction while 12 others passed in First Class.

One of Pratham Mysore programs is Read India. Currently, over 5,000 students participate in the program which has been developed to make every child read, write and do basic math by utilizing Reading and Math packages of Pratham Mysore. This effort is carried out by Pratham volunteers without any monetary compensation. There are several other related in-school programs run by Pratham.

For pre-schools education, Pratham runs a number of Balawadis for children 3-5.5 yrs old, and also partners with the Karnataka state government to strengthen the state run Anganwadi pre-schools.

## CLASS OF 1969 SCHOLARSHIP PROJECT

In 2014, the Panjab University Alumni Class of 1969 from the Department of Chemical Engineering updated their 4 merit-cum-means scholarships of INR 5,000/Yr each for one freshman, sophomore, junior, and senior. The university agreed to triple the scholarship amount to INR 15,000/Yr each for a one-time contribution of \$5,000. The scholarships requires that the applicant complete some positive community service. The letter below provides additional details on the project which was coordinated by Bhav Sharma with full and enthusiastic support from 10 classmates from the Class of '69.

Subject:- Award of "Class of 1969" Alumni Scholarships for undergraduate students of B.E (Chem. Engg. & Tech.,) @ Rs. 1500/- p.m. each for 10 months for the year 2014-2015.

Dear Sir,

Applications of eligible students are invited for the award of Four Scholarship cited above to the undergraduate students of B.E(Chem. Engg. & Tech.,) Panjab University, Chandigarh. The amended rules for the award are given below:-

1. The scholarship be known as "Class of 1969 Alumni scholarships".
2. Four scholarships be paid one each for under graduate classes of Ist, IIrd, IIIrd & IVth year of University of Chem. Engg. & Tech.(UICET), on merit-cum-means basis @ Rs. 1500/-p.m. each for 10 months.
3. The applicant must have cleared all of his/her immediate past semesters Examinations with at least 60% marks. There should be no backlog from the immediate past semesters. The student's family income should be no more than Rs. 3 Lakh per year.
4. The student should be willing to perform at least 10 hours of Volunteer work of his/her choice. A few examples are as follows but the student is free to perform any positive service to society:
  - a. Volunteer work at the UICET library
  - b. Volunteer tutoring of Klin worker's children near the University
  - c. Volunteer work at the University Library
  - d. Volunteer work for activities such as a community clean up or off campus
  - e. Volunteer work at the sector 25 Government School
  - f. Tutoring of one or more children from very poor families such as the unorganized sector
  - g. Any service to help the poor of the society
5. The student has to complete the volunteer work by Feb 28. A one page summary of the volunteer work needs to be e-mailed to Indian Schools Alumni & Friends, USA(INSAF) at [sharma7336@gmail.com](mailto:sharma7336@gmail.com) with a copy to the UICET Chairperson at [DCET@PU.ac.in](mailto:DCET@PU.ac.in) by March 10 of every year.
6. Upon timely submission of the volunteer work summary, the scholarship recipient will be awarded the Class of 1969 Alumni Scholarship Certificate by March 31.
7. The recipient of this scholarship will be free to accept to any other scholarships.
8. Prof. S.K Sharma is nominated to be a representative on the scholarship administration committee.
9. The scholarships will be awarded on the recommendations of a committee to be constituted by the Vice-Chancellor.

You are requested to forward the applications of the eligible candidates in view of the term and conditions mentioned above positively by 20.10.2014.

The Literacy Mission volunteers (about 60) work with the children at nearby slum areas, and try to ensure they go to school, and tutor them on a regular basis. Under this project, one bright student named Madu (2nd from left outside her humble home), will be supported for her educations costs towards a B.Sc.



## SNACKS FOR CHILDREN AT SOS RAJPURA, PUNJAB

About 8 years ago, a 10-15 yr commitment was made by **Kumar & Sudesh Kapur, Joginder & Meera Kundra, Raj & Padmashri Lad, Ash & Darshan Mehan, Sucheta Sachdev, and Bhav & Kaye Sharma** to support 6 children at a cost of \$160 per child per year at SOS Children's Village, Rajpura, Punjab. All the children are progressing nicely — the eldest now being a very good student in the 11th grade .

During 2014, Kumar & Sudesh Kapur decided to sponsor a one-time treat (snacks) for all the children and staff at the Children's Village at Rajpura. A contribution of \$70 allowed such a treat for almost 200 children and staff on Children's Day which is on November 14 (photos below). The project was facilitated by INSAF India.

## MAHADEV SHISHU MANDIR, ALLAHABAD, UP

The Mahadev Shishu Mandir is a middle school in Allahabad, U.P. with 340 students, about 150 of whom are girl students. The school serves children from disadvantaged families.

This year, INSAF President Dr. Ramesh and his wife Ms. Pratibha Paliwal have decided to initiate support for the school with the intent of continuing longer-term. A contribution of \$250 has been sent to the school to help with the purchase of a computer for the school.

## CYCLONE DEVASTATES AREA IN ANDHRA

In October 2014, the cyclone Hudhud hit coastal Andhra Pradesh. The large village of Chipurupalli, where Sodhana is situated, is located about 92 Km from the city of Vishakhapatnam. Sodhana founder and managing wrote the following updates:

Oct. 19: "All trees in visakhapatnam are uprooted. It is a city without any trees. feel very sad to see it. Don't know what happen to all the birds that live on these trees. .. Most up the crops in our villages are wiped out. It will take at least 6 months to get things going again. We want to send part of our team to visakhapatnam to help in the cleaning operations. Other members of our team will study the crop damage in our villages. We only pray god to give the effected people more strength to face this unforeseen calamity."

Nov 3: "The cyclone has caused a lot of damage to all the standing crops. Banana, Papaya, Cane sugar and Corn plantations are completely destroyed. The only aid the villagers received so far from the Govt. is 25 Kgs Rice, 3 Kgs Potatoes, 1 Kg Sugar and 1 Litre cooking oil. Number of teams from the Govt. side are coming and assessing endlessly the loss incurred by farmers. But they have not received any relief towards their crop and plantation loss. Most of our team members and our community have also suffered crop losses because of the cyclone. This is causing a dip in their annual income. Though Sodhana can take care of them to certain extent in the form of remunerations and medical and educational aid, they all also need a little bit of support from the Govt."

In view of these events, the INSAF support team for Sodhana is to consider whether some one-time extra support can be provided. In the meanwhile, contributions of \$4,900 and of INR 20,500 have been sent.
