RECORD LEVEL OF PROJECT EFFORT IN 2014; YR 2015 ON LOWER TRAJECTORY

Everyone associated with INSAF can take pride in the fact that our collective project effort in 2014 was the best in INSAF's 42 year operational history. Bravo.

The total project effort in 2014 was at \$121,730 which is an 18% increase from the \$103,001 in 2013. For perspective, INSAF's previous best was Yr 2006 with \$110,701.

Page 5 has our "Project Honor Roll" for 2014, which shows the depth and breadth of the project effort. The **number** of projects, which indicates "breadth", was 35 relative to 28 in 2013, an improvement. The **median** amount per project can be taken as an indicator of depth. The average dollars per project in Yr 2014 was \$600, down from \$1,600.

Of course, each project is unique in how it makes a difference, and these numbers only provide a partial perspective. Here are the types of causes our INSAF colleagues chose to support in 2014:

Generalized Description for Project Goal

- Literacy and good quality education for poor children
- Care and education for "out-of-system" or otherwise disadvantaged children
- Operation or upgrade of an educational institution
- Pre-school education for village children
- College education of disadvantaged youth
- Funding for community service
- Incentivize and motivate students to perform better
- Support for work on women's empowerment
- Community health services

Project effort in Yr 2015 at the time of this Newsletter is on a much lower trajectory than that in 2014, but we still have almost 7 months to go. Would you like to "give back" in some way during 2015 and need any help? Please let the Newsletter Editor or any Board Member know.

DUE DILIGENCE: Project Leaders are requested to obtain documentation on how specifically the funds were used at the recipient organization (rather than a general receipt) and help INSAF maintain a good standard on due diligence.

ONLINE AND MATCHING CONTRIBUTIONS TO INSAF

FYI — one can contribute online to INSAF through a Paypal account. At INSAFWEB.ORG, there is a button at the top of the home page which says "DONATE" via Paypal. This option has the advantage of convenience — you are all done with just a few clicks anytime 24/7. No need to write and mail a check. The flip side is that although 100% of your contribution is tax deductible, a fee will be deducted by Paypal. In most cases, about 97.5% of the funds will be available for your project.

Does your employer have a charitable contribution matching program? Examples of those already matching employee contributions for INSAF are: AT&T, Exxon Foundation, Gap, Google, Macy's, McGraw Hill, The Christensen Fund, and Tyco. INTRODUCING THE 2015-17 INSAF BOARD

Dr. Ramesh Chandra Paliwal (Chairman & President) retired from AT&T in December, 2014, as Senior Project Manager and Senior Technical Architect. Ramesh was born in Kakore (U.P.). He obtained his Bachelor's in Mech. Eng. from Banaras Hindu Univ. (1964), MS in Mech. Eng. from Univ. of Minnesota (1968), and Ph. D. in Mech. Eng. from Rutgers Univ. (1979). After his MS degree, Ramesh
